Hutton Energy's statement on the Minister of Environment of the Czech Republic's announcement of moratorium on shale gas exploration till 30 June, 2014

(Prague, 3 September, 2012)

David Messina, Executive Director, Hutton Energy:

Hutton Energy regrets the decision of the Minister of Environment Tomáš Chalupa to announce moratorium on shale gas exploration in the Czech Republic till 30 June, 2014.

- The ban on shale gas exploration is difficult to understand and questionable in its
 ability to be implemented. Many components of shale gas exploration are identical to
 any other oil and gas exploration. If it is Hydraulic Fracturing that is the concern then
 the government should focus on this aspect, and not shale gas exploration.
- We suspect that focussing on Hydraulic Fracturing would be an issue for the government as this method has been used in the Czech Republic for 20 years without incident.
- We are therefore sceptical about the true motivation for the proposed legislation changes, as it does not address one of the key concerns in the Czech Republic which is Hydraulic Fracturing.
- Hutton Energy does not propose to drill a well in the Czech Republic until 2015 which
 removes any possibility of undertaking Hydraulic Fracturing before this time. Hutton
 Energy, like the Minister of Environment, has always said that technology will improve
 by this time and the process will be even safer and more acceptable to community.
 Prior to undertaking any drilling program Hutton Energy has committed to undertake
 a full Environmental Impact Assessment, like we do in other countries, and all the key
 issues will be debated by all stakeholders at this time. It is unrealistic and not
 relevant to undertake that process today when our drilling and fracturing plans
 are at least three years away.
- Hutton Energy has not been successful in gaining a meeting with the Minister of Environment and is disappointed he has made this decision in the absence of any dialogue with industry which is clearly one of the stakeholders in this process.
